TAERNCON 2024 REGULATIONS

I. General information

- 1. TaernCon 2024 Convention, which is not a mass event as understood by provisions of the act of 20 March 2009 on the safety of mass events published in Journal of Laws 2009, no. 62, item 504 (hereinafter referred to as "Convention" or "Taerncon 2024") on the premises of the Czasoprzestrzeń at ul. Tramwajowa 1-3 in Wrocław 51-621 is organized by Krzysztof Danilewicz, running a business under the name "Krzysztof Danilewicz Whitemoon System", NIP: 8971695262, ul. Szolc Rogozińskiego 22, 53-209 Wrocław.
- 2. The organizer is responsible for the proper course of the Convention in accordance with applicable law, whereas owner of the facility is responsible for fire safety.
- 3. The condition for ensuring order and safety of the participants of the Convention is absolute abidance by all participants of the Convention of the provisions contained in these Regulations, compliance with the provisions of criminal law and the law of misdemeanor.
- 4. The Equipment operating at the Convention, provided by the Organizer, has been made and maintained to a standard allowing convenient, cultural and safe use of thereof in accordance with its purpose.
- 5. Early registration for the Convention is required and only those who registered beforehand will be admitted into the TaernCon 2024 area. Registration is made through the Google Form available at:

until 15.06.2024 in accordance with the information available at the website: https://brokenranks.com/en/news/. It is a public event conditional on following generally accepted rules of conduct and order in public places. Participation in TaernCon 2024 is free of charge, hoverer it will be possible to purchase food, drinks and other consumer goods at the premises of the Convention for a fee.

6. Information about the Convention has been published by the Organizer on the website: https://brokenranks.com/en/news/ and marked them in the title with the name "TaernCon 2024."

II. Organizational and order rules in force at the area of the Convention

- 1. TaernCon 2024 takes place on 6 July 2024. In justified cases the Organizer may change the date of the Convention, or cancel it having announced it first.
- 2. The facility where the Convention will be held, will be insured for the third-party liability insurance of the facility owner and the Organizer's insurance against consequences of unfortunate accidents.

- 3. The participants of the Convention are obliged to strictly follow the instructions and recommendations of Organizer's Security Service at the convention and people responsible for the Convention.
- 4. The following definitions used in the Regulations shall have the following meaning:

"Identifier" means the identifier issued by the Organizer when entering the Convention based on previously created list of attendance. The Identifier will have the form of a tag on an advertising lead with Organizer's logo. Its design will be set by the Organizer. The Identifier will contain information about Attendee's nickname and server on which s/he plays. One Identifier may be used by one person only. Damaged or torn Identifier is void. Giving Identifiers away is forbidden.

"Security Services" and "Information Services" mean people appointed by the Organizer, including employees of the security or property protection agencies identifying themselves with and identifier, to handle security of people participating in TaernCon 2024, including checking the right of Attendees to enter the Convention Area. Security Service and Information Service personnel hold visible identifiers containing: issuer's name, identification number and photo, validity period, issuer's stamp and signature.

"Facility" or "Area" mean the building of the Czasoprzestrzeń at ul. Tramwajowa 1-3 in Wrocław, or any other place where TaernCon 2024 may be relocated for important reasons and announced in a public message before the Convention.

"Attendee" means a person attending the Convention on a basis of the Identifier. Minors who are not 18 years old yet may attend the convention, but only under supervision of an adult throughout the duration of the Convention. Underage Attendees are also obliged to present a consent signed by their parent/guardian for the underage person's stay on the premises of TaernCon 2024. The consent must be submitted at the moment of collecting the Identifier before entering TaernCon 2024 at the latest.

- 5. It is forbidden to bring to the Convention:
- a) weapons,
- b) alcohol,
- c) dangerous objects and tools,
- d) explosives and pyrotechnical products,
- e) drugs and psychotropic substances,
- f) poisonous substances and radionuclides,
- g) liquids and other flammable substances,
- h) beverages in glass containers.
- 6. Additionally, it is forbidden to:

- a) park cars outside the parking area,
- b) bring dogs to the convention,
- c) destroy information boards, benches, lawns and any small and large architecture objects,
- d) enter or pass over all sorts of fencings,
- e) enter areas that are out of bounds for attendees of the Convention,
- f) throw objects of any kind,
- g) Conduct commercial and gastronomic activities without consulting the Organizer,
- h) sell, advertise, canvass and fundraise without Organizer's permission,
- i) litter the area,
- j) enter the premises of the Convention Area with symptoms of an infectious diseases.
- 7. Security Service has the right, in justified cases, to ask for identification and check contents of luggage and clothing of persons attending the Convention. Such persons are obliged to undergo the identification procedure aimed at establishing their identity, as well as undergo external search and inspection of their luggage.
- 8. Those inebriated or under the influence of drugs, as well as those refusing to undergo the procedures described in point 6 above, or those disturbing the proper course of the Convention will be removed by Security Services.
- 9. In case of extraordinary events, all attendants of the Convention are required to follow the instructions given through the sound system by the Organizer and Security Service staff. The instructions may be in particular related to: the necessity to leave the Convention Area due to occurred danger stating the manner of behavior, reminding of nearby exits from the Convention Area, and behaving in a strictly defined way that ensures safety of all participating in the Convention.
- 10. The organizer undertakes to comply with the provisions of the act of 26 October 1982 on upbringing in sobriety and counteracting alcoholism (Journal of Laws no. 35, item 230 with amendments), in particular, alcohol consumption is allowed only in designated places and only by adults.

III. RIGHTS AND OBLIGATIONS OF the Organizer and Attendees:

- 1. Organizer of the Convention is allowed to capture the run of TaernCon 2024, in particular the behavior of people, with devices capturing image and sound.
- 2. Persons disrupting the order, or violating these regulations will be removed from the Convention Area by the Security Service. In particularly dangerous cases they will be detained and handed over to the police or city guard.

- 3. In the event that the actions of the Security Service prove to be insufficient, it will apply for help to the Police.
- 4. If any item forbidden at the Convention is found among the checked luggage or clothing, a member of the Security Service will deny the individual carrying such items entrance to the Convention Area, or will remove such person from the Convention Area.
- 5. If the contents of the checked luggage or clothing are found to contain weapons, dangerous objects, alcoholic beverages, explosives, pyrotechnical and fire hazardous products, drugs or psychotropic substances, a member of the Security or Information Services will detain the person in whose luggage or clothing the said items were found. The objects will be confiscated and a report of that activity will be made. Such person, together with the confiscated objects, will be handed over to the police.
- 6. Persons denied from entering the convention and those removed from the Convention Area in accordance with the Regulations due to their violation, are not entitled to any reimbursement.
- 7. The Organizer also captures the run of the Convention to document and promote or advertise the Convention in the future years, the Organizer and sponsors. Image of people present at the Convention Area may be captured and publicized for documentary, reporting, advertising and promotional purposes. By entering the TaernCon 2024 Area the attendee agrees to have their image disseminated for the purposes described above.
- 8. During the Convention, the Organizer may organize contests with prizes. Detailed rules of these contests will be communicated to the Attendees during TaernCon 2024 at the Convention Area or on the event's website:

IV. COMPLAINTS:

- 1. Any complaints may be filed in writing no later than 14 days from the end of the Convention to the following mailing address, belonging to the Organizer: Krzysztof Danilewicz Whitemoon, ul. Szolc Rogozińskiego 22, 53-209 Wrocław, or at the email address: zlot@whitemoon.com.
- 2. The Organizer will settle filed complaints within 30 days from the date of their delivery to the Organizer by registered mail or e-mail message.
- 3. The condition for pursuing complaints is the exhaustion of the complaints procedure specified in this chapter of the regulations.

V. FINAL PROVISIONS:

- 1. All rights to the TaernCon 2024 name and logo are reserved for the Organizer. Official programs and gadgets related to the Convention will be sold exclusively at the Convention Area or in selling points authorized by the Organizer.
- 2. The status of the sponsor of the Convention is granted by the Organizer only.

- 3. The Organizer is not responsible for the consequences of force majeure.
- 4. These Regulations are available: on TaernCon 2024 website: http://brokenranks.com/en/news/taerncon-2024--schedule-location-signups; at the information points at the Convention Area and at the Identifier issuing point; made available via a Google form for approval to each Participant individually.
- 5. Correspondence to the Organizer should be sent to the address indicated in point IV.1. Of the Regulations in writing, by registered mail.
- 6. Security and Information Services may issue their own safety and fire instructions in accordance with applicable law.
- 7. In matters not covered by the Regulations, the provisions of generally applicable law shall apply.

VI. PERSONAL DATA:

- The controller of your personal data obtained in connection with the organization of the convention is Krzysztof Danilewicz conducting business under the name of Krzysztof Danilewicz Whitemoon System, based in Wrocław, S. Szolc-Rogozińskiego St. No. 22, 53-209 Wrocław, registered in the Central Register and Information on Business Activity under NIP: 8971695262, REGON: 020740661 (hereinafter: Controller or Whitemoon). The Controller can be contacted via e-mail address: ido@whitemoon.com.
- 2. The Controller processes personal data of the convention participant, such as e-mail address, nickname, image, and, if a complaint is filed, also the data indicated in the content of the complaint notification.
- 3. Personal data of the convention participant is processed:
 - 1. for purposes arising from legitimate interests pursued by the Controller or by a third party on the basis of Article 6 (1) (f) of Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016. on the protection of individuals with regard to the processing of personal data and on the free movement of such data and the repeal of Directive 95/46/EC (hereinafter: GDPR), i.e. in order to ensure the proper organization of the rally, to enable the conduct of the convention and to verify participants' compliance with the convention rules, as well as to handle complaints related to the convention and defend against claims;
 - 2. for the publication of promotional and marketing materials on websites/social media channels administered by Whitemoon on the basis of Article 6(1)(a) of the RODO, i.e. voluntary consent.
- 4. The Controller will provide personal data of the convention participant to the following categories of recipients: shipping service providers (couriers), postal service providers, IT service provider, persons to whom the Controller will grant access to the website/social media channels, email service provider, legal advisory service providers, and litigation attorneys representing the Controller.

- 5. Personal data of the convention participant will be stored, in case of personal data processing for:
 - 1. organization of the convention until the end of the convention, including consideration of any complaints,
 - 2. publication of promotional and marketing materials on websites/social media channels administered by Whitemoon until withdrawal of consent,
 - 3. the proper conduct of the convention until the statute of limitations for claims,
 - 4. defense against claims until the claim is enforced or barred, whichever event occurs first.
- 6. A convention participant has the right to access, rectify, delete or limit processing of his personal data, as well as the right to object to processing.
- 7. A convention participant has the right to lodge a complaint to a supervisory authority, i.e.: President of the Office for Personal Data Protection (ul. Stawki 2, 00-193 Warsaw), if he/she considers that the processing of personal data is incompatible with the applicable law.
- 8. Provision of personal data by a convention participant is voluntary, however, refusal to provide personal data will prevent the participant from taking part in the convention.
- 9. Pursuant to Article 21(1) of the GDPR, a rally participant has the right at any time to object for reasons related to his or her particular situation to the processing of personal data based on the Controller's legally justified purpose.
- 10. The Controller does not process the personal data of convention participants based solely on automated processing, including profiling.
